

FACTS WHAT DOES THE KARRAS COMPANY DO WITH YOUR PERSONAL INFORMATION?

Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	The types of personal information we collect, and share depend on the product or service you have with us. This information can include: • Social Security number, tax identification number, date of birth and other identification • Address, telephone number and email address • Marital status, account balances, assets, income and other financial information
How?	All financial companies need to share clients' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their clients' personal information; the reasons The Karras Company ("us" or "we") chooses to share; and whether you can limit this sharing. Please note that we do not "sell" your personal information, with "sell" meaning the disclosure of personal information to a third party for monetary or other valuable consideration.

What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account—unless you tell us otherwise.

Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. • we do not have joint marketing partners or agreements
